My research activity has focused on the study of both personal and contextual variables associated with interpersonal relationships, such as social and moral competence, motivation, social and normative adjustment, peer group, the family, and its relationship with school violence (bullying and cyberbullying). I am the Principal Investigator of a European Project of the RIA call of the H2020 Program (755175) and a Plan Nacional I+D+I Program Project (PID2020-113911RB-I00) focused on the analysis and promotion of the social, emotional, and moral competence of schoolchildren. I have also directed a Regional Research Contract (art. 83 LOU) granted in a very competitive call of the Center of Andalusian Studies. From the last October, I am with Prof. R. Ortega-Ruiz the co-director of the Laboratorio de Estudios sobre Convivencia y Prevención de la Violencia (www.laecovi.com) where I used to be member from 2009 until now. I have been research member of several regional, national, and European projects developed above of the direction of Prof. Ortega-Ruiz from 2003 until 2014, that I granted my first own project as PI on a competitive call. I have published more than 30 articles in JCR journals in the last ten years, of which 24 are Q1 and Q2. I have published different articles with international authors from a variety of Universities as: University of Greenwich, King's College London, University of Flinders- Australia- University of Groningen, among others). I have supervised six doctoral PhD Theses and I am currently supervisor of five doctoral students, three with have been granted by the National Call (former FPU Grants). I am associate editor of the journal Educational Sciences: Theory & Practice and a member of the editorial team of several journals such as Educational Psychology and Psychology, Society & Education. I have participated as a speaker in invited symposia and presented scientific papers in more than thirty national and international conferences and I was a Guest Speaker (KeyNote) at the II World Antibullying Forum (2018, Dublin, Ireland).
